AGM report

The CPCA Annual General Meeting was held at the Churton Park Community Centre on 28 March 2025. It was attended by 40 people, 21 of whom were current CPCA members.

The meeting began with the award of Life Membership of the CPCA to John Morrison for his long service, both to the Association and to the wider Churton Park Community. John was an elected member of the CPCA Executive Committee between 2008 and 2020. He was Vice President from 2010 to 2020 and remains an active member of the Association, maintaining the website and providing a constant stream of support and advice.

This was followed by a summary by WCC Northern Ward Councillors Ben McNulty and John Apanowicz of the Wellington City Council Long-Term Plan Amendment, and Annual Plan for 2025/26.

After considering reports of the past year's work, elections were held to appoint officers for the year ahead. These were:

In the following weeks, CPCA reluctantly received the resignation of Kevin Arlidge, due to his other extensive commitments as President of the Returned & Services Association (RSA). Kevin had been Vice President of CPCA and had led our work in emergency response

planning. His contributions and experience will be sorely missed.

Simon Haynes and Stuart Trounson also resigned.

Constitution

On 24 June 2025 the New Zealand Companies Office accepted CPCA's application to reregister Churton Park Community Association as an incorporated society under the provisions of the Incorporated Societies Act 2022.

This followed submission of our Constitution, as approved at the 2025 AGM, a copy of which can be viewed in the CPCA website.

Review of the constitution

The AGM also noted that, in response to some concerns raised, the incoming committee would further review the Constitution over the coming year. This will take place over the next few months, allowing CPCA to lodge an amendment if required, following discussions and decisions at the 2026 AGM.

Local Body Elections - 11 October 2025

Wednesday 27 August 5-10 pm

Mayoral Candidates, at Johnsonville Community Centre Hall.

Wednesday 17 September 5-10 pm

Northern Candidates, at Johnsonville Community Centre Hall.

The events allow short presentations by each of the candidates, followed by answers to questions from electors.

Please make time to hear what your candidates have to say, and take the opportunity to ask them questions.

Enrol to have your say

If you're on the electoral roll, you can vote in the local elections where you live.

You can enrol if you're 18 or older, a New Zealand citizen or permanent resident, and have lived in New Zealand for more than one year continuously at some time in your life.
